# **Public Hearing**

At 9:53 p.m. Trustee Economou moved to open the public hearing on Local Law 2 of 2024 which would repeal Local Law 1 of 2024 overriding the tax levy limit established by general municipal law, which was seconded by Trustee Schloss and unanimously approved.

Mayor Liguori asked for any comments from the Board or the public.

There being no comments, Trustee Fagen moved to close the public hearing at 9:54 p.m. which was seconded by Trustee Bardong and unanimously approved.

At 9:55 p.m. Trustee Economou moved to open the public hearing on the on the application for tree removal submitted by Howard and Lori Fensterman, owner of parcel designated as Section 15 Block 206 Lot 60 located at 25 Stone Hill Road to remove 83 trees, total caliper inches of 816 which was seconded by Trustee Fagen and unanimously approved.

Mayor Liguori asked the applicant to come forward and detail the request. Tony Toscano, Superintendent of Public Works reviewed the application and presented his findings to the Board.
